

1.1 A bill for an act

1.2 relating to human services; modifying group residential housing and Minnesota
1.3 supplemental aid shelter needy provisions; modifying adult foster care homes;
1.4 amending Minnesota Statutes 2010, sections 245A.11, subdivisions 2, 2a, 7,
1.5 7a, 8; 245B.07, subdivision 1; 245C.04, subdivision 6; 256B.092, subdivision
1.6 1b; 256D.44, subdivision 5; 256I.04, subdivision 2a; 326B.103, by adding a
1.7 subdivision; proposing coding for new law in Minnesota Statutes, chapters 245B;
1.8 256B; repealing Minnesota Rules, part 9555.5105, subpart 37, item B.

1.9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.10 Section 1. Minnesota Statutes 2010, section 245A.11, subdivision 2, is amended to read:

1.11 Subd. 2. **Permitted single-family residential use.** Residential programs with a
1.12 licensed capacity of six or fewer persons shall be considered a permitted single-family
1.13 residential use of property for the purposes of zoning and other land use regulations
1.14 and the State Building Code, sections 326B.101 to 326B.191, except that a residential
1.15 program whose primary purpose is to treat juveniles who have violated criminal statutes
1.16 relating to sex offenses or have been adjudicated delinquent on the basis of conduct in
1.17 violation of criminal statutes relating to sex offenses shall not be considered a permitted
1.18 use. This exception shall not apply to residential programs licensed before July 1, 1995.
1.19 Programs otherwise allowed under this subdivision shall not be prohibited by operation of
1.20 restrictive covenants or similar restrictions, regardless of when entered into, which cannot
1.21 be met because of the nature of the licensed program, including provisions which require
1.22 the home's occupants be related, and that the home must be occupied by the owner, or
1.23 similar provisions.

1.24 Sec. 2. Minnesota Statutes 2010, section 245A.11, subdivision 2a, is amended to read:

2.1 Subd. 2a. **Adult foster care license capacity.** (a) The commissioner shall issue
2.2 adult foster care licenses with a maximum licensed capacity of four beds, including
2.3 nonstaff roomers and boarders, except that the commissioner may issue a license with a
2.4 capacity of five beds, including roomers and boarders, according to paragraphs (b) to (f).

2.5 (b) An adult foster care license holder may have a maximum license capacity of five
2.6 if all persons in care are age 55 or over and do not have a serious and persistent mental
2.7 illness or a developmental disability.

2.8 (c) The commissioner may grant variances to paragraph (b) to allow a foster care
2.9 provider with a licensed capacity of five persons to admit an individual under the age of 55
2.10 if the variance complies with section 245A.04, subdivision 9, and approval of the variance
2.11 is recommended by the county in which the licensed foster care provider is located.

2.12 (d) The commissioner may grant variances to paragraph (b) to allow the use of a
2.13 fifth bed for emergency crisis services for ~~a person with serious and persistent mental~~
2.14 ~~illness or a developmental disability~~ persons with disabilities, or for respite services as
2.15 defined in section 245A.02, regardless of age, if the variance complies with section
2.16 245A.04, subdivision 9, and approval of the variance is recommended by the county in
2.17 which the licensed foster care provider is located. Respite services may be provided
2.18 under the following conditions:

2.19 (1) staffing ratios cannot be reduced below the approved level for the individuals
2.20 being served;

2.21 (2) no more than two different individuals can be accepted for respite services in
2.22 any calendar month;

2.23 (3) the person receiving respite services must have his or her own bedroom, which
2.24 could be used for alternative purposes when not used as a respite bedroom, and cannot use
2.25 the room of another person who lives in the foster care home; and

2.26 (4) individuals living in the foster care home must be notified when the variance
2.27 is approved. The provider must give 60 days' notice in writing to the residents and their
2.28 legal representatives prior to accepting the first respite placement. Notice is not required
2.29 prior to each subsequent placement.

2.30 (e) ~~If the 2009 legislature adopts a rate reduction that impacts providers of adult~~
2.31 ~~foster care services,~~ The commissioner may issue an adult foster care license with a
2.32 capacity of five adults if the fifth bed does not increase the overall statewide capacity of
2.33 licensed adult foster care beds in homes that are not the primary residence of the license
2.34 holder, ~~over the licensed capacity in such homes on July 1, 2009,~~ as identified in a plan
2.35 submitted to the commissioner by the county, when the capacity is recommended by

3.1 the county licensing agency of the county in which the facility is located and if the
3.2 recommendation verifies that:

3.3 (1) the facility meets the physical environment requirements in the adult foster
3.4 care licensing rule;

3.5 (2) the five-bed living arrangement is specified for each resident in the resident's:

3.6 (i) individualized plan of care;

3.7 (ii) individual service plan under section 256B.092, subdivision 1b, if required; or

3.8 (iii) individual resident placement agreement under Minnesota Rules, part
3.9 9555.5105, subpart 19, if required; and

3.10 (3) the license holder ~~obtains written and signed informed consent from~~ notifies each
3.11 resident or resident's legal representative documenting the resident's informed choice to
3.12 living in the home and that the resident's refusal to consent would not have resulted in
3.13 service termination; ~~and~~

3.14 ~~(4) the facility was licensed for adult foster care before March 1, 2009.~~

3.15 ~~(f) The commissioner shall not issue a new adult foster care license under paragraph~~
3.16 ~~(e) after June 30, 2011. The commissioner shall allow a facility with an adult foster care~~
3.17 ~~license issued under paragraph (e) before June 30, 2011, to continue with a capacity of five~~
3.18 ~~adults if the license holder continues to comply with the requirements in paragraph (e).~~

3.19 Sec. 3. Minnesota Statutes 2010, section 245A.11, subdivision 7, is amended to read:

3.20 Subd. 7. **Adult foster care; variance for alternate overnight supervision.** (a) The
3.21 commissioner may grant a variance under section 245A.04, subdivision 9, to rule parts
3.22 requiring a caregiver to be present in an adult foster care home during normal sleeping
3.23 hours to allow for alternative methods of overnight supervision. The commissioner may
3.24 grant the variance if the local county licensing agency recommends the variance and the
3.25 county recommendation includes documentation verifying that:

3.26 (1) the county has approved the license holder's plan for alternative methods of
3.27 providing overnight supervision and determined the plan protects the residents' health,
3.28 safety, and rights;

3.29 (2) the license holder has obtained written and signed informed consent from
3.30 each resident or each resident's legal representative documenting the resident's or legal
3.31 representative's agreement with the alternative method of overnight supervision; and

3.32 (3) the alternative method of providing overnight supervision, which may include
3.33 the use of technology, is specified for each resident in the resident's: (i) individualized
3.34 plan of care; (ii) individual service plan under section 256B.092, subdivision 1b, if

4.1 required; or (iii) individual resident placement agreement under Minnesota Rules, part
4.2 9555.5105, subpart 19, if required.

4.3 (b) To be eligible for a variance under paragraph (a), the adult foster care license
4.4 holder must not have had a ~~licensing action~~ conditional license issued under section
4.5 245A.06 or 245A.07 during the prior ~~24~~ 12 months based on failure to ~~provide adequate~~
4.6 ~~supervision, health care services, or resident safety in the adult foster care home~~ perform
4.7 any of the functions directly related to overnight supervision.

4.8 (c) A license holder requesting a variance under this subdivision to utilize
4.9 technology as a component of a plan for alternative overnight supervision may request
4.10 the commissioner's review in the absence of a county recommendation. Upon receipt of
4.11 such a request from a license holder, the commissioner shall review the variance request
4.12 with the county.

4.13 (d) For the purposes of this subdivision, "supervision" means oversight as specified
4.14 in the individual resident's place agreement and awareness of the resident's needs and
4.15 activities.

4.16 Sec. 4. Minnesota Statutes 2010, section 245A.11, subdivision 7a, is amended to read:

4.17 Subd. 7a. **Alternate overnight supervision technology; adult foster care license.**

4.18 (a) The commissioner may grant an applicant or license holder an adult foster care license
4.19 for a residence that does not have a caregiver in the residence during normal sleeping
4.20 hours as required under Minnesota Rules, part 9555.5105, subpart 37, item B, but uses
4.21 monitoring technology to alert the license holder when an incident occurs that may
4.22 jeopardize the health, safety, or rights of a foster care recipient. The applicant or license
4.23 holder must comply with all other requirements under Minnesota Rules, parts 9555.5105
4.24 to 9555.6265, and the requirements under this subdivision. The license printed by the
4.25 commissioner must state in bold and large font:

4.26 (1) that the facility is under electronic monitoring; and

4.27 (2) the telephone number of the county's common entry point for making reports of
4.28 suspected maltreatment of vulnerable adults under section 626.557, subdivision 9.

4.29 (b) Applications for a license under this section must be submitted directly to
4.30 the Department of Human Services licensing division. The licensing division must
4.31 immediately notify the host county and lead county contract agency and the host county
4.32 licensing agency. The licensing division must collaborate with the county licensing
4.33 agency in the review of the application and the licensing of the program.

4.34 (c) Before a license is issued by the commissioner, and for the duration of the
4.35 license, the applicant or license holder must establish, maintain, and document the

5.1 implementation of written policies and procedures addressing the requirements in
5.2 paragraphs (d) through (f).

5.3 (d) The applicant or license holder must have policies and procedures that:

5.4 (1) establish characteristics of target populations that will be admitted into the home,
5.5 and characteristics of populations that will not be accepted into the home;

5.6 (2) explain the discharge process when a foster care recipient requires overnight
5.7 supervision or other services that cannot be provided by the license holder due to the
5.8 limited hours that the license holder is on site;

5.9 (3) describe the types of events to which the program will respond with a physical
5.10 presence when those events occur in the home during time when staff are not on site, and
5.11 how the license holder's response plan meets the requirements in paragraph (e), clause
5.12 (1) or (2);

5.13 (4) establish a process for documenting a review of the implementation and
5.14 effectiveness of the response protocol for the response required under paragraph (e),
5.15 clause (1) or (2). The documentation must include:

5.16 (i) a description of the triggering incident;

5.17 (ii) the date and time of the triggering incident;

5.18 (iii) the time of the response or responses under paragraph (e), clause (1) or (2);

5.19 (iv) whether the response met the resident's needs;

5.20 (v) whether the existing policies and response protocols were followed; and

5.21 (vi) whether the existing policies and protocols are adequate or need modification.

5.22 When no physical presence response is completed for a three-month period, the
5.23 license holder's written policies and procedures must require a physical presence response
5.24 drill to be conducted for which the effectiveness of the response protocol under paragraph
5.25 (e), clause (1) or (2), will be reviewed and documented as required under this clause; and

5.26 (5) establish that emergency and nonemergency phone numbers are posted in a
5.27 prominent location in a common area of the home where they can be easily observed by a
5.28 person responding to an incident who is not otherwise affiliated with the home.

5.29 (e) The license holder must document and include in the license application which
5.30 response alternative under clause (1) or (2) is in place for responding to situations that
5.31 present a serious risk to the health, safety, or rights of people receiving foster care services
5.32 in the home:

5.33 (1) response alternative (1) requires only the technology to provide an electronic
5.34 notification or alert to the license holder that an event is underway that requires a response.
5.35 Under this alternative, no more than ten minutes will pass before the license holder will be
5.36 physically present on site to respond to the situation; or

6.1 (2) response alternative (2) requires the electronic notification and alert system
6.2 under alternative (1), but more than ten minutes may pass before the license holder is
6.3 present on site to respond to the situation. Under alternative (2), all of the following
6.4 conditions are met:

6.5 (i) the license holder has a written description of the interactive technological
6.6 applications that will assist the license holder in communicating with and assessing the
6.7 needs related to the care, health, and safety of the foster care recipients. This interactive
6.8 technology must permit the license holder to remotely assess the well being of the foster
6.9 care recipient without requiring the initiation of the foster care recipient. Requiring the
6.10 foster care recipient to initiate a telephone call does not meet this requirement;

6.11 (ii) the license holder documents how the remote license holder is qualified and
6.12 capable of meeting the needs of the foster care recipients and assessing foster care
6.13 recipients' needs under item (i) during the absence of the license holder on site;

6.14 (iii) the license holder maintains written procedures to dispatch emergency response
6.15 personnel to the site in the event of an identified emergency; and

6.16 (iv) each foster care recipient's individualized plan of care, individual service plan
6.17 under section 256B.092, subdivision 1b, if required, or individual resident placement
6.18 agreement under Minnesota Rules, part 9555.5105, subpart 19, if required, identifies the
6.19 maximum response time, which may be greater than ten minutes, for the license holder
6.20 to be on site for that foster care recipient.

6.21 (f) All placement agreements, individual service agreements, and plans applicable
6.22 to the foster care recipient must clearly state that the adult foster care license category is
6.23 a program without the presence of a caregiver in the residence during normal sleeping
6.24 hours; the protocols in place for responding to situations that present a serious risk to
6.25 the health, safety, or rights of foster care recipients under paragraph (e), clause (1)
6.26 or (2); and a signed informed consent from each foster care recipient or the person's
6.27 legal representative documenting the person's or legal representative's agreement with
6.28 placement in the program. If electronic monitoring technology is used in the home, the
6.29 informed consent form must also explain the following:

6.30 (1) how any electronic monitoring is incorporated into the alternative supervision
6.31 system;

6.32 (2) the backup system for any electronic monitoring in times of electrical outages or
6.33 other equipment malfunctions;

6.34 (3) how the license holder is trained on the use of the technology;

6.35 (4) the event types and license holder response times established under paragraph (e);

7.1 (5) how the license holder protects the foster care recipient's privacy related to
7.2 electronic monitoring and related to any electronically recorded data generated by the
7.3 monitoring system. A foster care recipient may not be removed from a program under
7.4 this subdivision for failure to consent to electronic monitoring. The consent form must
7.5 explain where and how the electronically recorded data is stored, with whom it will be
7.6 shared, and how long it is retained; and

7.7 (6) the risks and benefits of the alternative overnight supervision system.

7.8 The written explanations under clauses (1) to (6) may be accomplished through
7.9 cross-references to other policies and procedures as long as they are explained to the
7.10 person giving consent, and the person giving consent is offered a copy.

7.11 (g) Nothing in this section requires the applicant or license holder to develop or
7.12 maintain separate or duplicative policies, procedures, documentation, consent forms, or
7.13 individual plans that may be required for other licensing standards, if the requirements of
7.14 this section are incorporated into those documents.

7.15 (h) The commissioner may grant variances to the requirements of this section
7.16 according to section 245A.04, subdivision 9.

7.17 (i) For the purposes of paragraphs (d) through (h), "license holder" has the meaning
7.18 under section 245A.2, subdivision 9, and additionally includes all staff, volunteers, and
7.19 contractors affiliated with the license holder.

7.20 (j) For the purposes of paragraph (e), the terms "assess" and "assessing" mean to
7.21 remotely determine what action the license holder needs to take to protect the well-being
7.22 of the foster care recipient.

7.23 (k) The commissioner shall evaluate license applications using the requirements in
7.24 paragraphs (d) through (f). The commissioner shall publicly post guidance or criteria
7.25 used in evaluating applications.

7.26 (l) To be eligible for a variance under paragraph (a), the adult foster care license
7.27 holder must not have had a conditional license issued under section 245A.06 during
7.28 the prior 12 months.

7.29 (m) The commissioner shall approve or deny an application for an alternative
7.30 overnight supervision license within 60 days of receipt of the application. If no notification
7.31 is issued, the application shall be considered approved until written notification to the
7.32 applicant is issued by the commissioner. If the application is denied, the commissioner
7.33 shall provide a written explanation to the applicant listing the criteria that were not
7.34 satisfied and describe how the applicant may meet the criteria in order to be issued a
7.35 license. The commissioner shall allow the applicant to modify and update the application

8.1 to correct deficiencies. The commissioner shall respond to the updated application within
8.2 14 days of receipt of the updated application.

8.3 (n) For the purposes of this subdivision, "supervision" means oversight as specified
8.4 in the individual resident's place agreement and awareness of the resident's needs and
8.5 activities.

8.6 Sec. 5. Minnesota Statutes 2010, section 245A.11, subdivision 8, is amended to read:

8.7 Subd. 8. **Community residential setting license.** (a) The commissioner shall
8.8 establish provider standards for residential support services that integrate service standards
8.9 and the residential setting under one license. The commissioner shall propose statutory
8.10 language and an implementation plan for licensing requirements for residential support
8.11 services to the legislature by January 15, 2011.

8.12 (b) Providers licensed under chapter 245B, and providing, contracting, or arranging
8.13 for services in settings licensed as adult foster care under Minnesota Rules, parts
8.14 9555.5105 to 9555.6265, or child foster care under Minnesota Rules, parts 2960.3000 to
8.15 2960.3340; and meeting the provisions of section 256B.092, subdivision 11, paragraph
8.16 (b), must be required to obtain a community residential setting license.

8.17 (c) Providers of adult foster care licensed under this chapter and governed by the
8.18 standards in chapter 245B, are exempt from Minnesota Rules, chapter 4665.

8.19 Sec. 6. **[245B.065] COMMUNITY RESIDENTIAL SETTINGS.**

8.20 (a) Individuals who are receiving services under the community residential setting
8.21 license issued pursuant to section 245A.11, subdivision 8, shall have a support team to
8.22 help them make decisions regarding services. The team shall be composed of:

8.23 (1) the individual receiving services;

8.24 (2) the case manager or services coordinator;

8.25 (3) the individual's legal representative;

8.26 (4) the person's advocate, if any;

8.27 (5) other individuals chosen by the individual receiving services; and

8.28 (6) representatives of the providers of service, described in the individual service
8.29 plan, relevant to the needs of the individual.

8.30 (b) Support teams shall have the final decision regarding plans to mitigate the
8.31 individual's identified vulnerabilities. Based on an assessment by the support team, the
8.32 team may choose not to create a plan for identified vulnerabilities if the vulnerabilities do
8.33 not rise to the level of self neglect, maltreatment, or violations of the law. If the support
8.34 team chooses not to create a plan, the team must provide written documentation, signed by

9.1 all members of the team, supporting its decision. Licensors or other regulators shall not
9.2 have the authority to challenge the decision of the team.

9.3 (c) Support teams shall be included in any formal or informal evaluation of the
9.4 quality of services provided to an individual.

9.5 (d) Region 10 staff shall be consulted regarding establishment of a system to
9.6 evaluate the quality of services provided under the community residential setting license.

9.7 Sec. 7. Minnesota Statutes 2010, section 245B.07, subdivision 1, is amended to read:

9.8 Subdivision 1. **Consumer data file.** The license holder must maintain the following
9.9 information for each consumer:

9.10 (1) identifying information that includes date of birth, medications, legal
9.11 representative, history, medical, and other individual-specific information, and names and
9.12 telephone numbers of contacts;

9.13 (2) consumer health information, including individual medication administration
9.14 and monitoring information;

9.15 (3) the consumer's individual service plan.

9.16 (i) When a consumer's case manager does not provide a current individual service
9.17 plan, the license holder shall make a written request to the case manager to provide a
9.18 copy of the individual service plan and inform the consumer or the consumer's legal
9.19 representative of the right to an individual service plan and the right to appeal under
9.20 section 256.045;

9.21 (ii) In the event the case manager fails to provide an individual service plan after
9.22 a written request from the license holder, the license holder shall not be sanctioned or
9.23 penalized financially for not having a current individual service plan in the consumer's
9.24 data file.

9.25 (4) copies of assessments, analyses, summaries, and recommendations;

9.26 (5) progress review reports;

9.27 (6) incidents involving the consumer;

9.28 (7) reports required under section 245B.05, subdivision 7;

9.29 (8) discharge summary, when applicable;

9.30 (9) record of other license holders serving the consumer that includes a contact
9.31 person and telephone numbers, services being provided, services that require coordination
9.32 between two license holders, and name of staff responsible for coordination;

9.33 (10) information about verbal aggression directed at the consumer by another
9.34 consumer; and

9.35 (11) information about self-abuse.

10.1 Sec. 8. Minnesota Statutes 2010, section 245C.04, subdivision 6, is amended to read:

10.2 Subd. 6. **Unlicensed home and community-based waiver providers of service to**
10.3 **seniors and individuals with disabilities.** (a) Providers required to initiate background
10.4 studies under section 256B.4912 must initiate a study before the individual begins in a
10.5 position allowing direct contact with persons served by the provider.

10.6 (b) ~~The commissioner shall conduct~~ Except as provided in paragraph (c), the
10.7 providers must initiate a background study annually of an individual required to be studied
10.8 under section 245C.03, subdivision 6.

10.9 (c) After an initial background study under this subdivision is initiated on an
10.10 individual by a provider of both services licensed by the commissioner and the unlicensed
10.11 services under this subdivision, a repeat annual background study is not required if:

10.12 (1) the provider maintains compliance with the requirements of section 245C.07,
10.13 paragraph (a), regarding one individual with one address and telephone number as the
10.14 person to receive sensitive background study information for the multiple programs that
10.15 depend on the same background study, and that the individual who is designated to receive
10.16 the sensitive background information is capable of determining, upon the request of the
10.17 commissioner, whether a background study subject is providing direct contact services

10.20 (2) the individual who is the subject of the background study provides direct
10.21 contact services under the provider's licensed program for at least 40 hours per year so
10.22 the individual will be recognized by a probation officer or corrections agent to prompt
10.23 a report to the commissioner regarding criminal convictions as required under section
10.24 245C.05, subdivision 7.

10.25 Sec. 9. Minnesota Statutes 2010, section 256B.092, subdivision 1b, is amended to read:

10.26 Subd. 1b. **Individual service plan.** The individual service plan must:

10.27 (1) include the results of the assessment information on the person's need for service,
10.28 including identification of service needs that will be or that are met by the person's
10.29 relatives, friends, and others, as well as community services used by the general public;

10.30 (2) identify the person's preferences for services as stated by the person, the person's
10.31 legal guardian or conservator, or the parent if the person is a minor;

10.32 (3) identify long- and short-range goals for the person;

10.33 (4) identify specific services and the amount and frequency of the services to be
10.34 provided to the person based on assessed needs, preferences, and available resources.

11.1 The individual service plan shall also specify other services the person needs that are
11.2 not available;

11.3 (5) identify the need for an individual program plan to be developed by the provider
11.4 according to the respective state and federal licensing and certification standards, and
11.5 additional assessments to be completed or arranged by the provider after service initiation;

11.6 (6) identify provider responsibilities to implement and make recommendations for
11.7 modification to the individual service plan;

11.8 (7) include notice of the right to request a conciliation conference or a hearing
11.9 under section 256.045;

11.10 (8) be agreed upon and signed by the person, the person's legal guardian
11.11 or conservator, or the parent if the person is a minor, and the authorized county
11.12 representative; and

11.13 (9) be reviewed by a health professional if the person has overriding medical needs
11.14 that impact the delivery of services.

11.15 Service planning formats developed for interagency planning such as transition,
11.16 vocational, and individual family service plans may be substituted for service planning
11.17 formats developed by county agencies.

11.18 Approved, written, and signed changes to a consumer's services shall be an
11.19 addendum to that consumer's individual service plan.

11.20 Sec. 10. **[256B.492] ADULT FOSTER CARE VOLUNTARY CLOSURE;**
11.21 **ALTERNATIVES.**

11.22 Subdivision 1. **Definitions.** (a) The following definitions apply for the purposes
11.23 of this section.

11.24 (b) "Closure" means the cessation of operations of an adult foster care home,
11.25 licensed under Minnesota Rules, parts 9555.5105 to 9555.6265.

11.26 (c) "Closure plan" means a plan to close a foster care home.

11.27 (d) "Commencement of closure" means the date on which residents and designated
11.28 representatives are notified of a planned closure as part of an approved closure plan.

11.29 (e) "Completion of closure" means the date on which the final resident of the adult
11.30 foster care home designated for closure in an approved closure plan is discharged from
11.31 the adult foster care home.

11.32 (f) "Partial closure" means the licensed capacity of the adult foster home has been
11.33 decreased by the department.

12.1 (g) "Planned closure rate adjustment" means an increase in the operating rate of an
12.2 adult foster care home resulting from a planned closure or planned partial closure of
12.3 another adult foster care home.

12.4 Subd. 2. **Applications for planned closure of adult foster care homes.** (a) By
12.5 August 15, 2012, the commissioner shall implement and announce a program for closure
12.6 or partial closure of adult foster care homes. Names and identifying information provided
12.7 in response to the announcement shall remain private unless approved according to the
12.8 timelines established in the plan. The announcement must specify:

12.9 (1) the criteria in subdivision 3 that will be used by the commissioner to approve or
12.10 reject applications; and

12.11 (2) the information that must accompany the application.

12.12 (b) To be considered for approval, an application must include:

12.18 (3) if available, the proposed relocation plan for current residents of the adult foster
12.19 care home designated for closure. If a relocation plan is not available, the application must
12.20 include a statement agreeing to develop a relocation plan; and

12.21 (4) documentation, in a format approved by the commissioner, that all adult foster
12.22 care homes receiving a planned closure rate adjustment under the plan have accepted joint
12.23 and several liability for recovery of overpayments under section 256B.0641, subdivision
12.24 2, for the adult foster care home designated for closure under the plan.

12.25 (c) The application must address the criteria in subdivision 3.

12.26 Subd. 3. **Criteria for review of application.** In reviewing and approving closure
12.27 proposals, the commissioner shall consider, but not be limited to, the following criteria:

12.29 (2) development of alternative services that reduce the cost of care to the Medicaid

14.4 (b) Payment for nonrecurring special needs must be allowed for necessary home
14.5 repairs or necessary repairs or replacement of household furniture and appliances using

14.8 (c) A fee for guardian or conservator service is allowed at a reasonable rate
